- if the student card was handed in at the university, confirmation of the university that the student card had been handed in (form available at the university)
- details of a valid bank account

The application must be submitted within one month after admission to an admission-restricted degree programme. The application can only be granted if the prerequisites are met and the student card has been submitted.

- **withdrawal from university**

As evidence, I enclose all of the following:

- withdrawal from the university from which the refund is requested by the first day of lectures (copy of evidence: withdrawal application (*Antrag auf Exmatrikulation*) and withdrawal certificate (*Exmatrikulationsbescheid*))
- if the student card was handed in at the university, confirmation of the university that the student card had been handed in (form available at the university)
- details of a valid bank account

The application must be submitted within the first 14 days of the lecture period. The application can only be granted if the prerequisites are met and the student card was submitted.
